

**Bayshore Gardens Park & Recreation District
Board of Trustees Annual Budget Hearing Meeting
Thursday; June 25, 2026, at 7:00 P.M.**

Preliminaries - Roll call was taken, and a quorum was established. Meeting was called to order at 7:03 P.M. by Chairman Cori Howell. The Pledge of Allegiance was conducted.

Trustees Attending - Barbara Susdorf, Kyle Weatherly, Eric Talman, Terry Zimmerly, Cori Howell, Skip Wilhoit, Dan Rawlinson, and Keely Brown.

Trustee Absent - Barbara Greenberg

Also Attending - Gia Cruz, District Office Manager and Jeannette Sparrow, District Office Assistant.

Welcome - Chairman C. Howell welcomed the public attending the hearing and thanked them for their participation. She also read the rules for the evening and invited residents to cast their ballots.

"The ballot box shall be available those present may cast their ballot at will. They do not need to remain for the balance of the meeting, however, if an additional vote is taken and the resident owners are no longer present, they have surrendered their right to vote in that additional balloting." She asked everyone to please be respectful in what they say and, in whispering, so that everyone can hear the person speaking. She stated the proposed budget being presented tonight is for an increase of \$150.00 annually (not monthly).

Reading of the Resolutions - Resolutions 2026-06 and 2026-07 were read aloud by Treasurer, T. Zimmerly.

Treasurer's Report - T. Zimmerly presented an overview of the District's current & historical financial positions.

Public Questions and Comments - There were comments and questions received from the public attending the meeting. (3-minute time limit) Comments were both pro and con about the proposed budget and increase. C. Howell closed the public comment period.

Call for the Vote - C. Howell called for the vote. The members of the board eligible to vote made public their votes. B. Susdorf, K. Weatherly, E. Talman, T. Zimmerly, and C. Howell voted yes. and K. Brown and S. Wilhoit voted no. A last call for votes was made and the balloting was then closed.

Volunteers for the Count - Jenny Smetters and John Woodruff were selected to tally the votes, with Adam Hange's oversight.

Voting Results - M. Woodruff read the results to all present, 71 against, and 35 in favor of adoption **Resolutions Failed for the \$150.00 proposed increase.**

K. Weatherly made a motion to accept an increase of \$75.00. E. Talman seconded. Motion Passed by Trustees eligible to vote B. Susdorf, K. Weatherly, E. Talman, T. Zimmerly, C. Howell, and S. Wilhoit voted yes. and K. Brown voted no.

Volunteers for the Count - Jenny Smetters and John Woodruff were selected to tally the votes, with Adam Hange's oversight.

Voting Results - M. Woodruff read the results to all present, 40 against, and 51 in favor of adoption **Resolutions Passes for the \$75.00 proposed increase.**

Motion to Adjourn - C. Howell made a motion to adjourn the meeting, T. Zimmerly seconded. Meeting adjourned at 8:39 P.M.
