Marlene introduced John Dawson, Master Gardener to present on Orchid care. John said the Master Gardeners Spring sale will be March 23, 9:00 to 1:00.

Presentation

John Dawson started the presentation with fun facts: Orchids are the largest flowering plant family. There are 26,049 Orchidaceae species found in 880 genera. Fossil records go back to over 15 million years. Found on all contents except Antarctica. Found in all US States. The closest living relative is Asparagus. Flowers are edible. Can live over 100 years. They are not as fragile or expensive as most believe. We have 26 Species in Manatee County. New names are registered in England.

There are four basic types of orchids: Epiphytes (air plants), Lithophytes (grow on rocks), Saprophytes (grow in decaying matter in forest floors), Terrestrials (send their roots into the soil).

John went over the two growing patterns and the parts of the flower (Sepal, Petal, Stigma, Anther). The orchid tag name breakdown was defined. Always keep the name tag with the orchid as it shows Genus, etc. White flowers attract night pollinators, moths. Some colorful blooms are created by adding coloring to the watering.

John warned that most orchids are killed by improper watering. Only the roots should be watered, and water should never be standing on the leaves. Water pH should be between 5.3 and 6.5. adding a small amount of fertilizer and a dash of Epsom salts is good. Tap water is generally pH7 and rain pH6.8. The trace minerals needed are nitrogen, phosphorus, Potassium, Sulfur, Calcium, Magnesium, Boron, Copper, Iron, Manganese, Molybdenum, and Zinc. Use nitrate nitrogen or ammoniacal nitrogen, NOT Urea.

The air is 78% nitrogen. Most of the orchid's nitrogen is from the air, thus 'air plant'. The orchid needs proper light, water, and air circulation. Growing temperatures depend on the plant. Always sanitize tools to avoid spreading pests and diseases.

Several local venders, suppliers, orchid societies were given for contact. John suggested that interested beginners spend time researching orchids online, going to nurseries and talking with growers and buy large plants in bloom. John demonstrated how to trim (roots), transplant and stabilize a transported orchid using wire clips. It takes about eight years from seed to bloom. There are simple treatments for pests and fungi. At times cinnamon is also a secret ingredient. Enjoy the success of growing an orchid. And remember to always keep the orchid name tag. We thanked John Dawson for a wonderful presentation.

Kathy Rowe presented the 'Thought of the Day'. "Today I blossom with joy and beauty. Thank you, Life". We enjoyed the sweet refreshments provided by Suzanna Young. Thank you all. See you in March.
